

**THE CORPORATION OF THE TOWN OF RAINY RIVER**

**BY-LAW 1557-11**

---

Being a by-law for the purpose of establishing and regulating accessible parking locations.

---

The Town Council of the Corporation of the Town of Rainy River deems it in the best interest of the Town of Rainy River to establish accessible parking locations throughout the Town of Rainy River.

The purpose of this by-law shall be for the regulating and establishing of the following areas hereby designated as accessible parking and marked in accordance in the provisions of the *Highway Traffic Act* and the regulations there under.

Further, the said locations shall be designated by sign and properly painted.

And further, no vehicle shall be parked in the designated location without displaying the proper permits issued by the Ministry of Transportation for accessible parking.

And further, no person shall park a vehicle in a parking space designated for disabled persons unless a currently valid Accessible Parking Permit has been issued to that person, organization or to a passenger being picked-up or transported in the vehicle and such permit is displayed on or in the vehicle in accordance with the requirements of the HIGHWAY TRAFFIC ACT, R.S.O. 1990 c. H.8.

And further, any vehicle found parked in the designated accessible parking location without proper identification, i.e. permit, shall be towed away and stored at the owner's expense.

And further, the Corporation of the Town of Rainy River shall not be responsible for any damages which may occur during the towing and storage of the offending vehicle.

Designated Locations

1.	Fourth Street, 300 block	East	Last parking location north of Broadway Avenue (in front of the Rainy River Public Library and Service Ontario)
2.	Fourth Street, 200 block	East	First parking location south of the lane/driveway between True Value and the Post Office
3.	Fourth Street, 200 block	East	First parking location north of lane/driveway south of Rainy River Drugs
4.	Fourth Street, 100 block	West	First parking location south of Mill Avenue in front of the Medical Centre
5.	Fourth Street, 100 block	East	First parking location south of Mill Avenue in front of CIBC
6.	First Street, 300 block West		First parking location North of Broadway Avenue (in front of the
